**Subject:** Harnett County Republican Party Exempt Sales Plan signed October 29, 2018

During a cursory review of records for the Harnett County Republican Party (the Committee) as part of the approval process for an Exempt Sales Plan (ESP) received by the Agency on October 31, 2018, the Reviewer identified several anonymous contributions received by the Committee during the 2016 and 2018 Election Cycles. After the Committee provided additional records for review during a series of in-person, email, and telephone contacts with the Reviewer, a Forfeiture totaling \$2,449.21 was calculated.

The Forfeiture Agreement was in process when the ESP expired on December 31, 2018. As a result, a decision regarding approval of the Plan was not documented.

The Forfeiture Agreement between the Committee and the Agency to address the identified anonymous contributions was subsequently enacted March 26, 2019.
