This letter serves as notification that NCDHHS has concluded the compliance review process for Balanced Nutrition, Inc. for 2023-2024. The State agency has made multiple attempts to schedule an in-person exit conference, by email, telephone, and written communication, with no response.

This letter summarizes the disallowances associated with the findings from the Federal Fiscal Year 2023-2024 Compliance Review on Balanced Nutrition, Inc, Agreement #9460.

NCDHHS has issued disallowance forms to Balanced Nutrition, Inc. resulting in the following:

- \$24,400.29 in disallowances for the test facilities under the sponsorship of Balanced Nutrition, Inc. included in the compliance review.

- \$107,718.57 in disallowances for the Sponsoring Organization (\$86,560.57 for centers and \$21,158.00 for day care homes).

The full disallowance owed by Balanced Nutrition, Inc. to the State agency is \$132,118.86.
