**PLAINTIFF’S MEMORANDUM OF
LAW IN OPPOSITION TO
DEFENDANT GOPAC INC.’S
MOTION TO DISMISS FOR LACK OF
PERSONAL JURISDICTION**

NOW COMES Plaintiff T. Craig Travis, by and through his undersigned counsel, and offers the following authority in opposition to Defendant GOPAC, Inc.’s motion to dismiss for lack of personal jurisdiction pursuant to Rule 12(b)(2) of the North Carolina Rules of Civil Procedure.

FACTUAL & PROCEDURAL BACKGROUND

1. Plaintiff T. Craig Travis (“Mr. Travis”) is a citizen and resident of Rockingham County, North Carolina. Mr. Travis served on the Rockingham County Board of Commissioners (“Board of Commissioners”) from January 2011 through December 2022. He was a candidate for the Board of Commissioners in the 2024 Republican primary election.
2. Defendant GOPAC, Inc. (“Defendant GOPAC”) is a foreign non-profit corporation incorporated under the laws of the Commonwealth of Virginia. Defendant GOPAC is a tax-exempt political organization under 26 U.S.C. § 527 in that it functions to influence, or attempt to influence, the selection, nomination, election, and appointment of individuals to federal, state, and local public offices.

3. Defendant P. Kevin Berger (“Defendant Berger”) was one of Plaintiff’s opponents in the 2024 Republican primary race for the Rockingham County Board of Commissioners.

Defendant Berger’s father, Senator Phil Berger, Sr. (“Senator Berger”), who represents Rockingham County and has been the President Pro Tempore of the North Carolina Senate since January 26, 2011, is,^{1, 2} and all times relevant to the events alleged in the Complaint in this action was, a member of Defendant GOPAC’s Legislative Leaders Advisory Board. A LinkedIn post from the Chairman of Defendant GOPAC announcing Defendant GOPAC’s 2023 State Leaders Advisory Board is attached hereto as **ATTACHMENT 1** and incorporated by reference herein. An email sent by Defendant GOPAC (contact@gopac.org) at 11:50 a.m. on January 24, 2024 announcing Defendant GOPAC’s 2024 Legislative Leaders Advisory Board is attached hereto as **ATTACHMENT 2** and incorporated by reference herein.

4. Defendant North Carolina Conservatives Fund (also known as Eastern Carolina Conservatives Fund, Eastern Carolina Conservative Fund, North Carolina Conservative Fund, and NC Conservatives Fund) (“Defendant NCCF”) is a domestic non-profit corporation incorporated under the laws of North Carolina. Like Defendant GOPAC, Defendant NCCF is a tax-exempt political organization under 26 U.S.C. § 527 in that it functions to influence, or attempt to influence, the selection, nomination, election, and appointment of individuals to federal, state, and local public offices.

5. Royce E. Everette, Jr., who is the president and director of Defendant NCCF, filed

articles of amendment with the North Carolina Secretary of State on February 16, 2024, to change the name of Defendant NCCF from Eastern Carolina Conservative Fund to North Carolina Conservatives Fund.

6. Based on independent expenditure reports filed by Defendant NCCF with the North Carolina Board of Elections, Defendant GOPAC was the sole source of funding for Defendant NCCF from January 1, 2024 through December 31, 2024.

7. On February 16, 2024—the same day that Eastern Carolina Conservative Fund changed its name to North Carolina Conservatives Fund—the following events³ occurred:

- a. Defendant NCCF received a \$25,000.0 contribution from Defendant GOPAC.
- b. Defendant NCCF disbursed \$6,193.10 to Defendant Atlas Political Consulting, LLC (“Defendant APC”), a domestic limited liability company organized under the laws of North Carolina with its principal place of business in Wake County, North Carolina, for direct mail communications opposing Plaintiff’s candidacy for the 2024 Republican primary race for the Rockingham County Board of Commissioners. The direct mail communications financed by Defendant GOPAC, through Defendant NCCF, began on February 16, 2024.
- c. Defendant NCCF disbursed \$5,464.50 to Defendant APC for direct mail communications opposing Plaintiff’s candidacy for the 2024 Republican primary race for the Rockingham County Board of Commissioners. The direct mail communications financed by Defendant GOPAC, through Defendant NCCF,

began on February 21, 2024.

d. Defendant NCCF disbursed \$6,193.10 to Defendant APC for direct mail communications opposing Plaintiff's candidacy for the 2024 Republican primary race for the Rockingham County Board of Commissioners. The direct mail communications financed by Defendant GOPAC, through Defendant NCCF, began on February 26, 2024.

e. Defendant NCCF disbursed \$6,193.10 to Defendant APC for direct mail communications opposing Amy Lee Simpson's candidacy for the 2024 Republican primary race for the Rockingham Register of Deeds. The direct mail communications financed by Defendant GOPAC, through Defendant NCCF, began on February 20, 2024.

8. The false, derogatory mailers sent by Defendant GOPAC, through Defendant NCCF and Defendant APC, to potential voters in the 2024 Republican primary election in Rockingham County are set out in paragraphs 59 and 60 of the Complaint in this action.

9. Defendant NCCF did not receive any other contributions or make any other disbursements except for the transactions described in paragraph 7(a)-(e) above through December 31, 2024, as evidenced by the Independent Expenditure Reports filed with the North Carolina Board of Elections by Defendant NCCF on July 1, 2024 and January 9, 2025, which are collectively attached as **ATTACHMENT 4** and incorporated by reference herein.

10. Defendant GOPAC's efforts to influence the 2024 Republican primary election for the Rockingham County Board of Commissioners through its defamatory direct mail campaign against Plaintiff was successful. Although the election night results on March 5, 2024 showed

that the top three candidates receiving the most votes in the 2024 Republican primary election for the Rockingham Board of Commissioners were Jeff Kallam, Defendant Mark F. Richardson (“Defendant Richardson”), and Plaintiff, Defendant Berger defeated Plaintiff by three (3) votes on March 11, 2024 after absentee and provisional ballots were counted. Defendant GOPAC’s improper influence of the outcome of this election gives rise to Plaintiff’s claims for libel *per se* and libel *per quod* against Defendant GOPAC.

Proceedings between Plaintiff and Defendants

11. On June 17, 2024, Plaintiff filed a Complaint, asserting substantive claims for libel *per se*, libel *per quod*, and slander, against the defendants in this case.
12. On July 12, 2024, the following motions were filed:
 - a. Defendant Berger, Defendant Richardson, Defendant Diane P. Parnell (“Defendant Parnell”), and Defendant Donald T. Powell (“Defendant Powell”) filed a Motion to Dismiss pursuant to Rule 12(b)(6) of the North Carolina Rules of Civil Procedure.
 - b. Defendant NCCF and Defendant APC filed a Motion to Dismiss pursuant to Rule 12(b)(6) of the North Carolina Rules of Civil Procedure.
 - c. Defendant Berger, Defendant Richardson, Defendant Parnell, Defendant Powell, Defendant NCCF, and Defendant APC (collectively, “North Carolina Defendants”) filed a Joint Motion to Designate Action as Exceptional Case Designation Pursuant to North Carolina Rule of General Practice 2.1 (“Motion for Exceptional Case Designation”).
 - d. Plaintiff filed an Objection to the North Carolina Defendants’ Motion for

Exceptional Case Designation.

13. On July 15, 2024, Defendant GOPAC filed a Motion to Dismiss pursuant to Rule 12(b)(2) and (6) of the North Carolina Rules of Civil Procedure.

14. On January 13, 2025, Plaintiff filed a Supplemental Objection to the North Carolina Defendants' Motion for Exceptional Case Designation.

15. A hearing on the North Carolina Defendants' Motion for Exceptional Case Designation was held on February 26, 2025. At the conclusion of the hearing, the Court orally rendered its decision denying the North Carolina Defendants' Motion.

16. On March 21, 2025, the Court entered an Order Denying Defendants' Motion to Designate Action as Exceptional Case Pursuant to North Carolina General Rule of Practice 2.1.

ARGUMENT

When a defendant challenges personal jurisdiction under Rule 12(b)(2) of the North Carolina Rules of Civil Procedure, the plaintiff bears the burden of establishing that jurisdiction exists. The Court must undertake a two-part analysis: (1) whether North Carolina's long-arm statute, N.C. Gen. Stat. § 1-75.4, statutorily permits the exercise of personal jurisdiction over the defendant; and (2) whether the exercise of that statutory power comports with the due process requirements of the Fourteenth Amendment to the United States Constitution. *Dillon v. Numismatic Funding Corp.*, 291 N.C. 674, 675, 231 S.E.2d 629, 630 (1977).

I. NORTH CAROLINA'S LONG-ARM STATUTE ESTABLISHES PERSONAL JURISDICTION OVER DEFENDANT GOPAC.

17. North Carolina's long-arm statute should be liberally construed to find personal jurisdiction over non-resident defendants to the full extent permitted by due process. *Dillon*, 291 N.C. at 676, 231 S.E.2d at 630-31 (citing *Chadbourn, Inc. v. Katz*, 285 N.C. 700, 705, 208 S.E.2d

676, 679 (1974). “In determining whether the ‘long-arm’ statute permits our courts to entertain an action against a particular defendant, the statute should be liberally construed in favor of finding jurisdiction.” *Strother v. Strother*, 120 N.C. App. 393, 395, 462 S.E.2d 542, 543 (1995) (citing *Marion v. Long*, 72 N.C. App. 585, 586, 325 S.E.2d 300, 302, *disc. review denied and appeal dismissed*, 313 N.C. 604, 330 S.E.2d 612 (1985)). Multiple provisions of N.C. Gen. Stat. § 1-75.4 confer personal jurisdiction over Defendant GOPAC in this case.

18. In this case, North Carolina has specific jurisdiction over Defendant GOPAC. A state may assert specific jurisdiction over a defendant where “the defendant has ‘fair warning’ that he may be sued in a state for injuries arising from activities that he ‘purposefully directed’ toward that state’s residents.” *Tom Togs, Inc. v. Ben Elias Indus. Corp.*, 318 N.C. 361, 366, 348 S.E.2d 782, 786 (1986) (quoting *Burger King Corp. v. Rudzewicz*, 471 U.S. 462, 472 (1985)).

A. Defendant GOPAC is engaged in substantial action within North Carolina, which allows the Court to exercise personal jurisdiction under N.C. Gen. Stat. § 1-75.4(1)d.

19. Under N.C. Gen. Stat. § 1-75.4(1)(d), the Court may exercise jurisdiction over a defendant who is engaged in substantial activity within this state, whether the activity is wholly interstate, intrastate, or otherwise.

20. Defendant GOPAC has deliberately engaged in political activity within North Carolina. Senator Berger and former Speaker of the North Carolina House of Representatives Tim Moore (“Speaker Moore”) were both members of Defendant GOPAC’s Legislative Leaders Advisory Board in 2023. Senator Berger is currently a member of the Advisory Board and was also a member in 2024. Senator Berger and Speaker Moore’s position on Defendant GOPAC’s Advisory Board has provided Defendant GOPAC with direct knowledge of and influence over

North Carolina politics. This connection facilitated Defendant GOPAC's strategic decision to fund political messaging in Rockingham County, which altered the outcome of at least one race in the 2024 Republican primary election.

21. The Rockingham County Board of Commissioners race was not the only North Carolina election Defendant GOPAC attempted to influence during the 2024 primary election cycle.

22. In February 2024, Defendant GOPAC spent at least \$1,502,640.10 on direct mail and other media expenses unsuccessfully supporting Grey Mills and opposing Pat Harrigan in the Republican primary race for North Carolina's 10th Congressional District ("NC-10"), as shown on the Report of Receipts and Other Disbursements filed with the Federal Election

Commission by Defendant GOPAC on March 19, 2024 attached hereto as **ATTACHMENT 5**, which is incorporated by reference herein. During February 2024, Defendant GOPAC also received \$1,250,000.00 in contributions from Randy Marion, Inc.,⁴ a domestic corporation incorporated under the laws of North Carolina with its principal place of business in Mooresville, North Carolina, as shown on the Political Organization Report of Contributions and Expenditures filed with the Internal Revenue Service by Defendant GOPAC on April 14, 2024 attached hereto as **ATTACHMENT 6**, which is incorporated by reference herein.

23. Defendant GOPAC received contributions in excess of \$1,000,000.00 from a North Carolina corporation and made close to \$2,000,000.00 in independent expenditures to affect the outcome of North Carolina elections during the 2024 primary election cycle. It would be unconscionable to permit a political organization in an adjacent state, such as Defendant

GOPAC, to engage in conduct intended to affect the decisions of North Carolina voters while at the same time holding that the organization is not answerable to the courts of this state where its influence operations result in injury to a North Carolina citizen.

24. Defendant GOPAC was engaged in substantial activity in North Carolina during the 2024 primary election, including contributing \$25,000.00 to Defendant NCCF to fund defamatory campaign materials targeting Plaintiff. These materials were distributed to voters in Rockingham County, North Carolina, directly impacting Plaintiff's reputation in his community and adversely affecting his candidacy for a seat on the Board of Commissioners. The funding and distribution of these materials, along with Defendant GOPAC's actions regarding the NC-10 Republican primary election, constitute deliberate and substantial activity within North Carolina and provide a basis for the Court to exercise personal jurisdiction over Defendant GOPAC in this state.

B. Jurisdiction exists under N.C. Gen. Stat. § 1-75.4(3), because Defendant GOPAC'S actions within North Carolina caused the injury to Plaintiff upon which his claims against Defendant GOPAC are based.

25. N.C. Gen. Stat. § 1-75.4(3) allows the Court to exercise personal jurisdiction in any action claiming injury to person or property within North Carolina arising out of an act or omission within this state by the defendant. "The statute requires only that the action 'claim' injury to person or property within this state in order to establish personal jurisdiction. The statute does not require there to be evidence of proof of such injury." *Fox v. Gibson*, 176 N.C. App. 554, 558, 626 S.E.2d 841, 843 (2006) (quoting *Godwin v. Walls*, 118 N.C. App. 341, 349, 455 S.E.2d 473, 480 (1995)).

26. For purposes of a defamation claim, the tortious injury "is generally held to occur

wherever the offending material is circulated.” *Keeton v. Hustler Magazine, Inc.*, 465 U.S. 770, 777, (1984) (citing Restatement (Second) of Torts § 577A, Comment a (1977)).

27. In *Saxon v. Smith*, the plaintiff alleged that a defamatory newsletter published by the defendants “was distributed to approximately 100 residents of North Carolina.” 125 N.C. App. 163, 170, 479 S.E.2d 788, 793 (1997). The North Carolina Court of Appeals held that the publication of defamatory material in North Carolina constitutes action within this state causing an injury to person, which confers personal jurisdiction over the defendants pursuant to N.C. Gen. Stat. § 1-74.4(3). *Id.*

28. Although Defendant GOPAC did not directly pay Defendant APC to produce and distribute the defamatory mailers described in paragraphs 59 and 60 of the Complaint, it is apparent that Defendant GOPAC transferred funds to Defendant NCCF, which paid Defendant APC to produce and distribute the defamatory mailers on the very same day it received those funds, to provide material support to Defendant Berger—the son of one of Defendant GOPAC’s Legislative Advisory Board members. Under these circumstances, Defendant NCCF was essentially acting as a conduit for Defendant GOPAC as a matter of convenience or as a way to conceal Defendant GOPAC’s involvement in a county-level Board of Commissioners race in one of North Carolina’s least populous counties. It would strain credulity for Defendant GOPAC to argue that it had no idea that the \$25,000.00 payment it made to Defendant NCCF would be used to publish material opposing Plaintiff’s candidacy.

29. Defendant GOPAC’S activities within North Carolina, specifically its collaboration with Defendant NCCF and Defendant APC, to fund, create, and distribute defamatory materials to influence the outcome of a Rockingham County primary election in North Carolina, constitutes

action within the state and allows the Court to exercise personal jurisdiction over Defendant GOPAC.

C. Defendant GOPAC is subject to personal jurisdiction under N.C. Gen. Stat. § 1-75.4(4)a, because solicitation or services activities were carried on within North Carolina on its behalf by Defendant NCCF and Defendant APC.

30. To exercise personal jurisdiction over a defendant pursuant to N.C. Gen. Stat. § 1-75.4(4)a, a plaintiff must establish: “1) an action claiming injury to a North Carolina person or property; 2) that the alleged injury arose from activities by the defendant outside of North Carolina; and 3) that the defendant was engaging in solicitation or services within North Carolina ‘at or about the time of the injury.’” *Fran’s Pecans, Inc. v. Greene*, 134 N.C. App. 110, 113, 516 S.E.2d 647, 649-650 (1999).

31. In *Fran’s Pecans, Inc.*, the plaintiff was a Georgia corporation with its principal place of business in Charlotte, North Carolina. 134 N.C. App. at 111, 526 S.E.2d at 648. The corporate defendant was a Georgia corporation with its headquarters in Augusta, Georgia. *Id.* at 111, 526 S.E.2d at 649. The defendant hired an employee of the plaintiff who had been responsible for sales and marketing for the plaintiff. *Id.* at 112, 526 S.E.2d at 649. Thereafter, the defendant “mailed 1,937 of its catalogs to North Carolina residents, 239 of whom placed orders totaling \$12,323.95 in sales.” *Id.* The plaintiff sued the defendant, contending that these sales opportunities were the result of its former employee “taking valuable information about [the plaintiff’s] trade secrets and proprietary information.” *Id.*

32. The North Carolina Court of Appeals held that the damage to the plaintiff’s business reputation and loss of potential profits constituted an injury within the meaning of N.C. Gen. Stat. § 1-75.4(4)a. *Id.* at 113, 526 S.E.2d at 650. The court further held that it was appropriate

for North Carolina to exercise personal jurisdiction over the defendant, because the defendant's "activities contributed to plaintiff's alleged injury and are proximate enough in time to fulfill the statute's requirements." *Id.* at 114, 526 S.E.2d at 650.

33. Plaintiff, a North Carolina resident, has alleged that he was injured by the defamatory mailers funded by Defendant GOPAC, which establishes the first and second requirements for the exercise of personal jurisdiction under N.C. Gen. Stat. § 1-75.4(4)a. Plaintiff has also alleged that Defendant NCCF and Defendant APC were acting on behalf of Defendant GOPAC as a civil co-conspirator, which satisfies the third statutory requirement. Thus, even if the Court determines that Defendant GOPAC's actions as alleged in the Complaint do not constitute acts by Defendant GOPAC within North Carolina sufficient to permit the exercise of jurisdiction pursuant to N.C. Gen. Stat. § 1-75.4(3), North Carolina nevertheless has jurisdiction under N.C. Gen. Stat. § 1-75.4(4)a.

II. EXERCISE OF PERSONAL JURISDICTION OVER DEFENDANT GOPAC COMPORTS WITH DUE PROCESS.

34. The exercise of personal jurisdiction over Defendant GOPAC satisfies constitutional due process requirements, which mandate that a defendant have "certain minimum contacts with [the forum state] such that the maintenance of the suit does not offend 'traditional notions of fair play and substantial justice.'" *International Shoe Co. v. Washington*, 326 U.S. 310, 316 (1945).

35. The minimum contacts test requires the Court to determine whether a defendant has "purposefully availed itself of the privilege of conducting activities within the forum State," thereby invoking the benefits and protections of its laws. *Hanson v. Denckla*, 357 U.S. 235, 253 (1958). Defendant GOPAC has purposefully availed itself of the privilege of conducting activities in North Carolina by:

- a. Providing substantial funding (\$25,000.00) specifically earmarked for political messaging in opposition to Plaintiff's candidacy in Rockingham County, North Carolina;
- b. Conspiring with North Carolina-based entities, Defendant NCCF and Defendant APC, to create and distribute campaign materials within Rockingham County, North Carolina;
- c. Receiving over \$1,000,000.00 in contributions from a North Carolina corporation, Randy Marion, Inc., during the 2024 primary election cycle;
- d. Spending nearly \$2,000,000.00 in an effort to influence the outcome of the 2024 Republican primary election for NC-10;
- e. Maintaining a connection to North Carolina politics through Senator Berger's and former Speaker Moore's positions on its Legislative Leaders Advisory Board;
- f. Deliberately targeting Plaintiff, a North Carolina political candidate in a county-level North Carolina election, and benefiting Defendant Berger—the son of one of its Advisory Board members.

36. Defendant GOPAC deliberately engaged in activity in North Carolina to influence a local election, making it reasonably foreseeable that any legal consequences of that conduct would subject Defendant GOPAC to jurisdiction in North Carolina courts. *See Calder v. Jones*, 465 U.S. 783, 788-90 (1984) (establishing the “effects test” for personal jurisdiction in cases involving defamation and other intentional torts).

37. Once minimum contacts are established, the Court must determine whether the exercise of jurisdiction would be reasonable and fair. The factors considered in the Court's analysis

include: (1) the burden on the defendant; (2) the forum state's interest in adjudicating the dispute; (3) the plaintiff's interest in obtaining convenient and effective relief; (4) the interstate judicial system's interest in obtaining the most efficient resolution of controversies; and (5) the shared interest of the several states in furthering fundamental substantive social policies. *Burger King Corp. v. Rudzewicz*, 471 U.S. 462, 476-77 (1985).

38. North Carolina has a strong interest in providing a forum for its residents who have been injured by out-of-state actors who purposefully direct their activities toward this state. North Carolina also has a significant interest in ensuring the integrity of its electoral processes, which Defendant GOPAC deliberately sought to influence through its funding of defamatory campaign materials targeting Plaintiff.

39. Defendant GOPAC, as a sophisticated political organization based in Virginia with a multi-state presence, would not face an undue burden in defending itself in North Carolina. Because of Defendant GOPAC's substantial involvement in North Carolina politics, including its connection to legislative leaders within North Carolina, defending itself in this forum would not be unduly burdensome or unexpected.

40. Plaintiff, as a North Carolina resident whose reputation and political campaign were injured in North Carolina, has a strong interest in obtaining relief in his home forum. The alleged defamatory statements were published to Rockingham County, North Carolina voters, and the harm occurred entirely within this state.

CONCLUSION

For the foregoing reasons, the Court should deny Defendant's GOPAC's motion to dismiss for lack of personal jurisdiction.
