Description of Fraud	<p>Current Rockingham County Commissioners Kevin Berger and Mark Richardson and former Commissioner Don Powell were sued in their personal/individual capacities for defamatory statements they made in political ads and otherwise while campaigning for office during the 2024 Republican primary election. The civil action by the plaintiff, Craig Travis, in Wake County File No. 24CV018884-910 was explicitly brought against Berger, Richardson, and Powell in their personal/individual capacities for non-official conduct, and none of the defendants ever contended that they were being sued in an official capacity. However, Mr. Travis recently received a letter from Travelers (The Charter Oak Fire Insurance Company) regarding a claim made on Rockingham County's government insurance policy on behalf of Berger, Richardson, and Powell erroneously listing Mr. Travis as the claimant with an inexplicable date of loss of 7/10/2023 for payment of Berger, Richardson, and Powell's legal fees to their privately-retained law firm (Dowling PLLC) for defense regarding Mr. Travis's claims against them as individuals. When questioned about this claim during a Rockingham County Board of Commissioners</p>

meeting on 1/20/2026, Berger acknowledged that the claim had been submitted. Using Rockingham County resources to pay for personal and/or political expenses (i.e. defense against campaign-related defamation claims) violates North Carolina General Statute §§ 14-90, 14-91, 14-92, 153A-99(e), and 153A-456.
